**JOINT MOTION TO MODIFY CERTAIN DEADLINES IN CASE MANAGEMENT
ORDER 11**

As discussed with the Court on July 13, 2009 in a telephonic conference, the parties have agreed to certain changes regarding dispositive and *Daubert* motions for the Initial Trial Pool plaintiffs from Arkansas and Missouri. CMO 11, ¶ A.7, sets forth Dispositive and *Daubert* motion deadlines which CMO 13, ¶ 3, limits to Initial Trial Pool plaintiffs from Arkansas and Missouri. The parties jointly move to modify CMO 11, ¶ A.7 as follows:

For all four cases selected in paragraph 6 above for trial, the parties must file any motions for summary judgment or motions to exclude or limit expert testimony under *Daubert* or for any other reason by **August 17, 2009**. Briefs in opposition to motions filed Plaintiffs must be filed by **September 10, 2009**. Briefs in opposition to motions filed by any of the Defendants must be filed by **September 17, 2009**. All reply briefs must be filed by **October 2, 2009**.

In addition, the parties jointly move to alter the expert disclosure deadlines set forth in CMO 11 ¶ 4, and formerly adjusted by agreement by the parties, as follows:

Plaintiffs' rebuttal reports shall be disclosed by **August 10, 2007**, and plaintiffs may supplement these reports to incorporate deposition testimony occurring on August 6 and 7 by **August 13, 2007**. Any surrebuttal reports from Defendants shall be disclosed by **August 17, 2007**.
